Project Description Narratives

Purpose, Scope, and Technical Approach:

This project consists of subprojects that are DOE directly managed. They include Agreements-in-Principle (AIP) grants to the States of Kentucky and Tennessee, DOE-ORO Program Management Support, the National Center of Excellence for Metals Recycle (NMECR), and funds necessary for the termination of the Lockheed Martin Energy Systems contract as the M&O Contractor. Also included in this PBS is funding for Pre 4/1/98 Post Retirement medical benefits resulting from the Contract change. DOE has agreed to provide grant funds to TN and KY to provide independent support of environmental programs at the Oak Ridge Reservation and Paducah Gaseous Diffusion Plant. The intent of the AIP grants is to provide for the administrative support necessary to oversee the requirements for the interagency agreements under CERCLA. The NCEMR facilitates the cost-effective recycle of clean and decontaminated metals at DOE sites across the country.

Project Status in FY 2006:

In FY 2006, the direct support activities except for LMES contract closeout will be continuing in support of the EM Program.

Post-2006 Project Scope:

The Directed Support activities will continue until there are no EM activities at the Oak Ridge Reservation.

Project End State

The scope of work in this PBS is support activities and does not have an end state.

Cost Baseline Comments:

The cost estimates in this PBS were based on extrapolation estimates. The extrapolation estimate was derived from historical cost data and based on a required level of effort to perform the task. It was assumed that the level of effort would remain the same as in previous years.

There are no hazards for the PBS activities except for normal office type hazards.

State and Federal contractor personnel in accordance to Federal and State laws and standards perform the work.
